



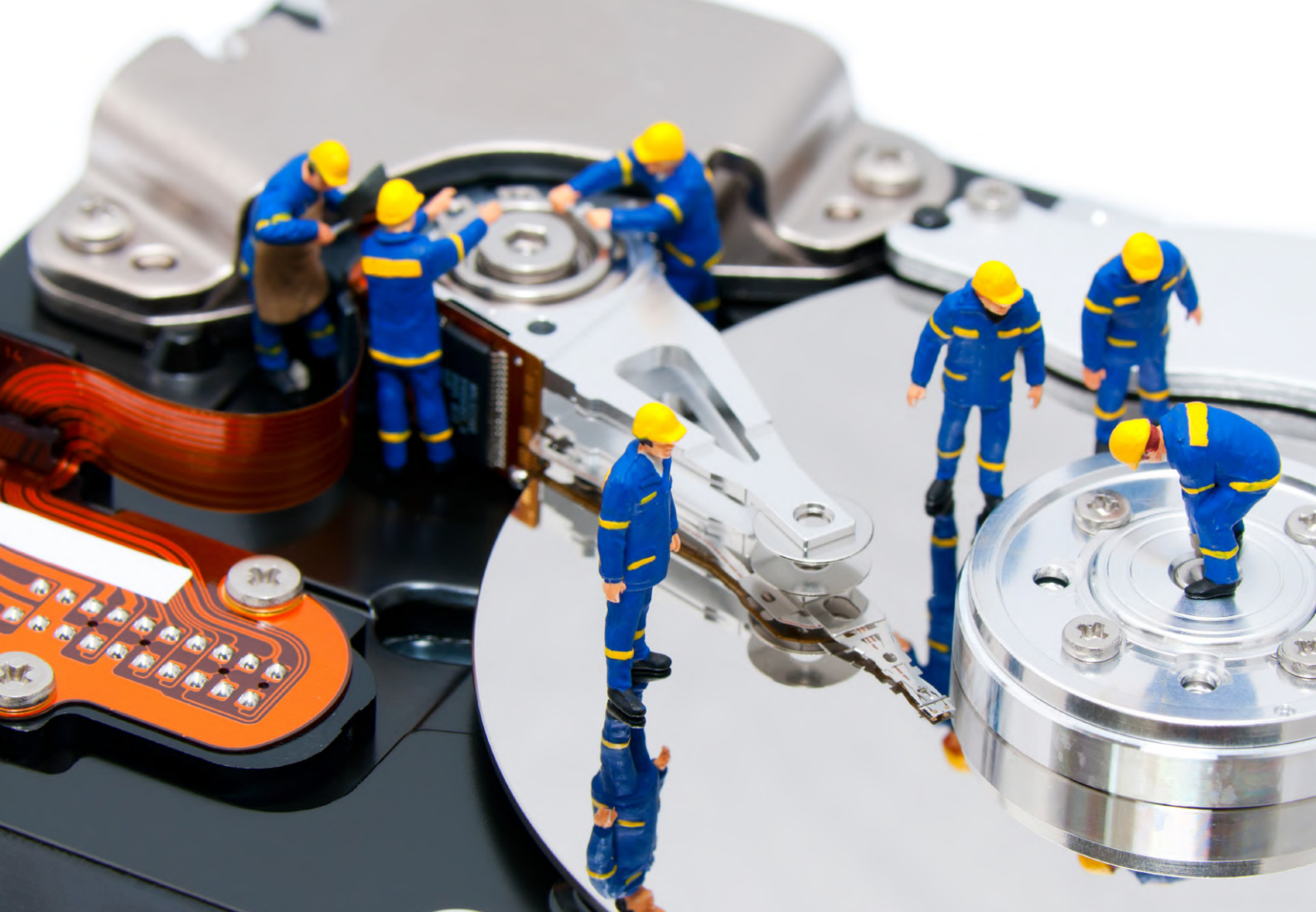

## Process

Our assignments typically run on the following lines:

- Identify which client operations staff will be nominated as contacts during the testing
- Determine staff and network/application availability and agree on a testing schedule
- Conduct penetration testing on agreed frequency
- Contact client support staff when a hacker attack pathway into your system is identified
- Send notification email on completion of the test including findings and recommendations

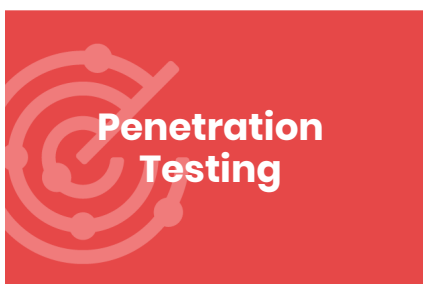
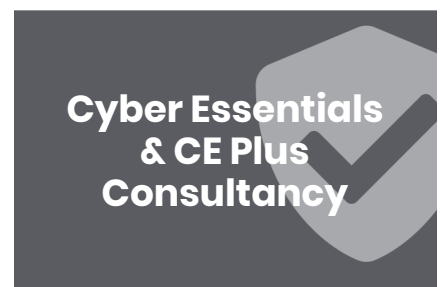
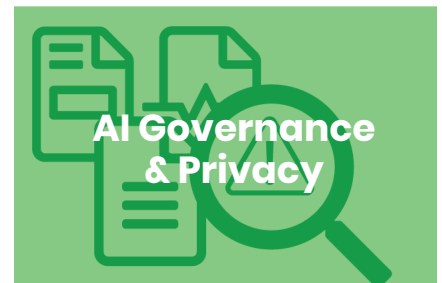
